


Our Logo

On the top right quarter is a gavel representing the might of the judiciary. Just below them, across the Nombril Point, runs a scroll bearing the inscription 'National Law University Odisha'. Below this is a representation of the Indian Constitution. Superimposed on the centre of the shield, centring on the Fess Point, is a Chakra or wheel from the Sun Temple at Konark, which represents the State of Odisha.

Our Motto

NLUO's motto has been sourced from Kautilya's Arthashastra, one of ancient India's great legal texts. In Chapter III, Book 1, Sloka 39, four varieties of law are identified, namely Dharma (sacral law), Vyavahara (transactional law), caritra (customary law), and Rajasasana (royal edicts). Sloka 40 determines the source of each type. In this context the book asserts, 'satye sthito dharmah' or 'Law locates in the truth'. This precept is surely as valid today as it was in Kautilya's times.

ACADEMIC PROGRAMMES

The University offers two five-year integrated undergraduate programmes, namely B.A. LL.B. (Hons.) and B.B.A. LL.B. (Hons.). The B.A. LL.B. (Hons.) programme combines the study of law with social sciences. As the part of inter disciplinary approach, courses on Sociology, Political Science, Economics, History, English language and Literature are taught under the social sciences discipline. The social science courses are specifically designed for novitiates and are aimed at introducing the basics of social sciences to the students. The B.B.A. LL.B. (Hons.) combines the study of law with management and finance. It offers foundational courses like Basic Principles of Accounting and Organisational Behaviour along with select modules on Management, Finance, Accounting and Economics.

In addition to undergraduate programmes, the university also offers LL.M. and Ph.D. Programmes. NLUO offers one year LL.M. programme with specialisation in Corporate Law and Constitutional Law. University also offers Ph.D. programmes in Law and as well as non-law streams particularly social sciences and management.

UNDERGRADUATE PROGRAMMES:

The university offers 5 years integrated undergraduate programmes of university namely, B.A.LL.B. (Hons.) and B.B.A.LL.B. (Hons.). The courses comprises of total 180 seats divided into 120 seats for B.A. LL.B. (Hons.) and 60 seats for B.B.A.LL.B. (Hons.). The admission to the said programmes are conducted through national level Common Law Admission Test (CLAT).

The students admitted in the academic year 2017-18 represents all the states of India and majority of them are from the state of Madhya Pradesh, Odisha and Uttar Pradesh.

POST-GRADUATE PROGRAMMES:

National Law University Odisha offers post graduate programme, namely, Masters of Law (LL.M). The programme is offered in two specialised streams - Constitutional and Administrative Laws and Corporate and Commercial Laws. The admissions to the said programme are done on the basis in Common Law Admission Test (CLAT). In the academic session 2017-18, 50 students were admitted.

DOCTORAL PROGRAMME:

The university has been offering Ph.D. programme since 2009. Admissions for doctoral programme is done on the basis of a separate entrance test.

So far five candidates have been conferred doctorate degree in Law. Ph.D. programme is offered in Law and as well as inter disciplinary streams particularly social sciences and management. The Ph.D. Programme is offered in three categories namely full-time, part-time and enrolment of in house faculty member/s.

Admissions in Ph.D. programme is two phase entrance process. Candidates with a minimum of 55% marks in masters can apply for the programme. At the first phase all the applicants are required to appear for the entrance test. Shortlisted candidates are required to submit a research proposal which is examined by research committee. On the recommendations of the committee, final list of the candidates admitted for the Ph.D. programme is declared.

NLUO GRANTED AUTONOMY BY UGC

The University Grants Commission (UGC) has granted autonomy to 60 higher educational institutes in India. This was announced by Shri Prakash Javadekar, Union Minister of Human Resource Development, Government of India on 20th March 2018.

This is a historical decision to acknowledge and recognise the Universities in India imparting quality teaching, research and learning. NLU Odisha is one amongst the sixty Universities in India to be recognised as a university imparting quality education. This recognition will provide another opportunity to innovate and experiment to develop vibrant academic learning.

This is the outcome of persistent efforts of our university in the field of education, learning and research. The universities granted with the autonomous status have the freedom to start new courses, off campus centers, skills development courses, research perks and anyother new academic programmes. The university as acknowledged by the Government of India have the freedom to hire foreign faculty, enrol foreign students, give incentive based emoluments to the faculty, enter into academic colloboration and run open distance learning programmes.

'Unnat Bharat Abhiyan' Programme of MHRD

The Ministry of Human Resource Development, Government of India, has launched 'Unnat Bharat Abhiyan (UBA)' with a view to connect the higher educational institutions to the villages around for transfer of knowledge to enrich rural India.

NLU Odisha is parterning with villagers to build change in Rural Development Processes under 'Unnat Bharat Abhiyan'. Being a part of te UBA, NLU Odisha envisages making transformational change in rural development processes by connecting students and teachers to strengthens community participation in planning and implementation of public welfare programs, and for the capacity building of the stakeholders of the rural development institutions. Based on the experiential learning the university will introduce Clinical Course on Rural Good Governance. The course would be designed to help students to understand rural issues and to identify innovative interventions to address the developmental challenges of rural Odisha.

The University will work with the five selected villages in Banki-Dompada Block of Cuttack district., namely: Amerendpur, Kusupangi, Baghua-Dompada, Mundali and Naraj.

FOURTH CONVOCATION (2017)

The Fourth Annual Convocation of the University was held on 18 November 2017. Hon'ble Mr. Justice Dipak Misra, Chief Justice of India & Visitor, NLUO was the Chief Guest for the occasion. Shri Naveen Patnaik, Chief Minister, Government of Odisha was the Guest of Honour. Hon'ble Mr. Justice Vineet Saran, Chief Justice of Orissa High Court & Chancellor, NLUO conferred the degrees to the students. Total 145 students were conferred degrees, out of which 114 were undergraduate students; 59 students of B.A L.L.B and 55 students of B.B.A L.L.B, 30 L.L.M students and one Ph.D degree were awarded. 18 gold medals were given to students in the convocation. The degrees and gold medals were awarded by the dignitaries.

The Convocation Address was delivered by Hon'ble Mr. Justice Dipak Misra, Chief Justice of India & Visitor, NLUO and Chief Guest for the occasion. NLUO Law Journal, Human Rights Law Journal, NLUO Students Journal and Child Rights Law Journal were released on this occasion. A book authored by Shri. Samareshwar Mahanty titled 'Maritime Jurisdiction and Admiralty Law in India' was also released. A host of dignitaries from the legal fraternity, parents of students, and staff of NLUO were also present in the occasion.




THIRD FOUNDATION DAY LECTURE

BAREFOOT LAWYERS COLLEGE

The University has established Barefoot Lawyers College under the scheme of UGC Community College to provide paralegal education in the state of Odisha. The concept of community college and paralegal is old and well recognised concept in western countries. The increasing importance of legal education in global economy provided an opportunity to develop paralegal courses in the country.

The Barefoot Lawyers College was established in February, 2016. The Barefoot Lawyers College offers two year course in "Advance Vocational Diploma in Paralegal Studies'.



It comprised of four semesters, and offers 16 public legal education courses, 12 vocational legal skills courses and 4 practicum courses of learning based on Internship and field work.

The Community College has successfully completed the first batch in February, 2018 as per the UGC guidelines. Along with the Diploma Course all the students have attended 45 days compulsory internship with renowned institutions like NGOs, Legal services Authorities, High Courts, District Courts, Advocates, UNICEF, Juvenile Justice Board, Child Welfare Committee, Family Courts, Public Sector Units, Various Commissions, various Research centres of State and NLUO etc.

STUDY ABROAD PROGRAMME IN LAW AND JUSTICE

The University organised a series of lectures for Australian Students in collaboration with Centurion University from 5th to 21st January 2018. As part of the programme. A team of 9 bachelors of law students from Victoria University (Australia) along with a faculty member participated to understand the constitutional principles and provisions which guides executive, Judicial and legislative matters in the country. The objective of the lecture series was to familiarise students with the functioning of the Indian legal system in the Indian political scenario.

The students gained knowledge on identification and evaluation of operational structures and interplay of a wide variety of factors like class, caste and gender. It also facilitated discussion on contemporary issues in Indian law and Justice. It provided an opportunity for them to develop a general understanding of the legal system in the backdrop of its cultural and historical heritage. They experienced a wide variety of Indian life and the chance to run workshop explaining concepts of law and justice in India. In addition to it, visitors along with student team of NLU visited legal aid clinics, District Court, and High court which helped clarify the cultural and social settings in which law and justice operate in India.



FACULTY DEVELOPMENT PROGRAMME

NLU Odisha has organised Three Faculty Development Programmes (FDP's) during 2017-18.

The first faculty development programme was conducted by the university jointly with IGNOU, New Delhi during May 8-10, 2017. This three days programme was conducted in order to on orient faculty members on "Open and Distance Learning". Prof Madhu Prahar, Prof. C. R. K. Murthy and Prof. Rampelli Satyanarayana of Staff Training and Research Institute of Distance Education (STRIDE), IGNOU, New Delhi to conduct this workshop. The workshop aims to help in development of Self Learning Materials for Teachers in Distance Learning.

The second Faculty Development Programme was conducted from 29 June - 1 July, 2017 on Curriculum Development, Preparation of Case Book/ Reading Materials and Research Methods. New Initiatives

Teaching Seminar Course

National Law University Odisha has always been committed to enriching the academic exposure of the students in various aspects of the legal profession so that they are best equipped to deal with the demands of their professional life. In furtherance of the same objective and in order to further expand the academic experience of the students, the University offers the Teaching Seminar Course from the Academic Session January-April 2017 to the 5th year and 4th year students in the under graduate programme and to the LL.M. students.

Under this programme, students are provided the opportunity to associate themselves with the under graduate courses in law and with the courses being offered by the University as part of the UGC Community College project to the students of Advanced Vocational Diploma in Paralegal Courses. The University is hopeful that apart from helping the students who are interested to pursue higher studies or are interested to join academics, the Teaching Seminar course will also provides them a unique learning opportunity.

Innovative Programmes

- University has offered and started the following innovative programmes:
- Foreign Language: University has started offering certificate courses in two foreign languages-French and German.
- Performing Arts: Certificate courses in Odissi dance and Indian music (Vocal) is being offered from 2017-18 academic year. This is offered jointly with the Sri Sri University.
- Innovative Courses as Part of Regular Curriculum: Regular course of Law & Entrepreneurship is being offered to the final year students. University also offered 7 single credit courses during the year.

Use of ICT in legal education

University is signing MoU with Indian Institute of Technology Bhubaneswar (IITB) to help and support our University in the following areas:- 1) Use of ICT for tracking of cases in Litigation Management Project. 2) Introduction of course on General Studies and Current Affairs. 3) Development of basic course on ICT for law students including Data Page and Programming relevant to lawyers and judges in India to inculcate use of technology in decision making, cyber law and cyber forensics.

Elective and Optional Courses:

The University has introduced several innovative courses as part of electives and optional courses. Some of the innovative courses are Media Law, RTI, Litigation Management, Maritime Law, Criminology, Mergers and Acquisitions, Corporate Insolvency, Copyright Law in the Entertainment Industry, Privileged Class Deviance, International Commercial Arbitration, Securities Law, Animal Welfare Law, Democracy, Election Law and Inclusive Governance, Medical Law and Ethics, Telecommunications and Broadcasting Law, Infrastructure Law, Laws on Mines and Minerals, International Criminal Law, Biotechnology Law etc. which are taught under seminar papers as part of the regular academic curriculum.

Out of the above mentioned courses Litigation Management in Higher Education course was introduced for the first time in January-May, 2017 session as a seminar cum clinical course. The purpose of the course is to integrate the study of litigation management with a project sanctioned to the University by Department of Higher Education, Government of Odisha.

Public Lecture

Second Sailabala Pujari Memorial Public Lecture

Hon'ble Justice Ruma Pal, Former Judge, Supreme Court of India delivered the Second Sailabala Pujari Memorial Public Lecture on "Judicial Recusal" at National Law University, Odisha on 31.03.2018 in the Seminar Hall of the Academic Block.

Hon'ble Justice Ruma Pal is the former judge of Supreme Court of India. She is a scholar – Judge who obtained B.C.L degree from St Anne's College, Oxford and started practice in Calcutta High Court in 1968. She was appointed as a judge of Calcutta High Court in 1990 and elevated to Supreme Court in January 2000. She was the Chancellor of Sikkim Central University from 2012-17 and one of the trustees of IDIA.

Advocate Sailabala Pujari was that first women legal practitioner and APP of the western Odisha. She has worked in different capacities such as Member of District Consumer Forum, Juvenile Justice Board and Legal Aid.



HEALTH AND WELLNESS COMMITTEE (YOUR DOST)

YourDost main objective is to empower the people to be their best by being their personal emotional wellness coach. It has ventured with NLUO to fulfil its objective to give mental and emotional support to the members of NLUO family. In view of the same, NLUO has formed the Health and Wellness committee for the proper functioning of YourDost and NLUO. On 17th August 2017, the Health and Wellness Committee had organised YourDost a one-day workshop wherein they spoke about " Men, Women and Worthiness" .The guest speakers were Mr. Puneet Manuja and Mr. JiniGopinat from YourDost Team.

In January 2018 a workshop on Psychological First Aid was conducted for the teaching staff held by Ms.Bhooma Krishnan. In February 2018 another workshop was conducted on Interpersonal Communication by Dr. Shilpa Srinath). This was followed by the March 2018 workshop in Mindfulness Workshop conducted by Mr. Varun Kaul and finally on April 2018 a workshop on "how to manage time" was conducted.

Regularly, emails and posters are distributed amongst students on various topics such *as* 5 Signs of Stress Worth Discussing With a Counselor', 6 Surprisingly Simple Ways To Beat Exam Stress', Mindfulness Workshop Promo FB Posts x 9, Emotional Wellness Test for NLUO students'.

For personal face-to-face counseling sessions, eminent psychologist Dr. Narendra alos visit the university on every Thursday. Different issues that students of NLUO sought support through Face to Face counseling are: Love & Relationships, Self-Improvement, Psychological Disorders, Academics, Career. Further, few things that are stressing students are that they can't deal with their emotions well, 86% of the students are constantly worried about their career and future, 41% of the students felt the constant pressure to improve themselves, 76% of the students stated that they feel judged, 63% of the students found it difficult to maintain relationships.

After starting YourDost in the campus, students have positive feedback about their overall emotional and academic growth. They find themselves more open to discuss their problems and come out with solutions with the help of teachers and Your Dost expert help and support.



CENTRE FOR DISTANCE EDUCATION:

The University has established Centre for Distance Education in the year 2015. It is currently in the process of developing the following programmes:

I. Course on Child Rights - The course on child rights is a comprehensive programme consisting of six modules to impart knowledge and awareness on contemporary issues of Child Rights and Juvenile Justice to all individuals and institutions involved in promotion and protection of Child Rights. The programme is supported by UNICEF and will be launched before the end of 2017.

ii. Course on Taxation - The new developments in the field of taxation, especially with the introduction of GST, taxation has become one of the most sought after branches of law. The increasing volume of disputes in the field of taxation has resulted in the manifold increase in the legal practitioners working in the field of taxation. Keeping this in mind, the Basic Course on Taxation Law is a unique initiative undertaken at NLUO. The Course is designed to provide an in-depth understanding of Taxation Law and practice. The course would be extremely useful to the candidates having wide-ranging background, from legal to scientific. This programme is aimed at individuals who wish to extend their professional expertise and combine it with a broad based understanding of the taxation structure. This course would also be offered by end of 2017.

iiii. Course on Right to Information - In order to encourage people to understand societal relevance of the Right to Information and its nuances, NLUO has decided to introduce a basic course in the subject. Though people understand the importance of RTI, it is not widely known how to go about it, what the technicalities are, how to frame the questions, how and where to make further appeals and related knowledge and awareness. The course and its content is developed after due deliberation and brainstorming with academicians and experts in the field.

Iv. PG MOOC Courses under SWAYAM: The University has applied for SWAYAM PG non- technology programme on Law and Justice in globalising world. This was submitted by Prof. (Dr.) Sri Krishna Deva Rao, Vice-Chancellor, NLU Odisha which was approved by the UGC.



RESEARCH PROJECTS

The university is established with the purpose of promoting research in law. To achieve this objective university is pursuing with the research projects as granted by government and other bodies.

Odisha State Child Labour Survey

Seeking total elimination of child labour in the state, Odisha government has formulated a "State Action Plan for Elimination of Child Labour". As a part of the said initiative the Department of Labour, Government of Odisha has entered into collaboration with NLUO for conducting of Child Labour Survey in Odisha. NLU, Odisha will provide the technical support for implementation of State Plan in the newly enacted Child and Adolescent Labour (Prohibition and Regulation) Amendment Act, 2016. As a part of the said initiative, the Labour Commissioner has also requested NLUO to finalize a team of researchers and professionals who would work with the Labour Department not just for the Survey but also in the long run for various intensive activities for elimination of Child Labour in the State of Odisha.

A Comparative Analysis of Performance Appraisal and Promotions of Subordinate Judiciary in India

This project is aimed at conducting a comparative analysis of the performance appraisal mechanism and schemes of promotion in relation to the judges of subordinate judiciary in different states. In addition to that, the research project also aims to identify the prevalent best practices and model mechanisms in relation to the performance appraisal and schemes of promotion of the judges (of subordinate judiciary) in different states and then make recommendations on the possibility of implementing uniform standards and policies concerning performance appraisal and schemes of promotion of the judges in different states.

Analysis of the Functioning of Lok Adalats in Eastern India

This project is aimed at studying the prevalent state of affairs as regards the functioning of Lok Adalats in the Eastern Region of India and then scrutinising the performance of Lok Adalats in terms of statistical parameters to have a more comprehensive understanding of the structural capacities and deficiencies. In addition to that, the project aims to identify the issues and factors which are impeding a more efficient functioning of the Lok Adalats, thereby also identifying the reformative measures through which the functioning of the Lok Adalats can be made more efficient.

Litigation Management in Higher education in the State of Odisha

This project is run by National Law University Odisha in collaboration with Department of Higher Education, Government of Odisha. Though huge numbers of cases are filed in courts every month, records of the pending cases in many departments. This project work commenced on February 20, 2017 and funded by World Bank will help the Government of Odisha in monitoring all the cases ongoing against them in addition to better utilisation of resources.

RESEARCH CENTRES

In order to promote research and extension in different areas of law and social sciences, the university has established number of research centres. These research centers include Centre for Child Rights, Centre for Access to Justice, Centre for Public Policy, Law , Good Governance, Centre for Human Rights & Criminal Justice, Centre for Disability Rights, Centre for Women and Law, Centre for Natural Resources Management, Centre for International Trade Law, Centre for Corporate Law, Intellectual property analysis and Advocacy Centre, Consumer Law Centre, Tribal Rights Advocacy Centre, Centre for Industrial Relations and Labour Laws, Alternative dispute Resolution Centre, Centre for Maritime Law and LexTech Centre-Centre for Law , Entrepreneurship and Innovation. Notable works of selected research centres are highlighted as under:

Centre for Child Rights (CCR)

Centre for Child Rights (CCR) is the specialized research centre of the National Law University Odisha, Cuttack. The Centre was established in the year 2015 with a mission to improve access to justice for children and promote research, advanced learning and advocacy to strengthen child rights laws, policies and practices in India. Seeking total elimination of child labour in the state, Odisha government has formulated a "State Action Plan for Elimination of Child Labour". As a part of the said initiative the Department of Labour, Government of Odisha has entered into collaboration with NLUO for conduction of Child Labour Survey in Odisha. NLU, Odisha will provide the technical support for implementation of State Plan in the newly enacted Child and Adolescent Labour (Prohibition and Regulation) Amendment Act, 2016. As a part of the said initiative, the Labour Commissioner has also requested the university to finalize a team of researchers and professionals who would work with the Labour Department not just for the Survey but also in the long run for various intensive activities for elimination of Child Labour in the State of Odisha.

The Centre had undertaken following activities during April 2017 to March 2018 with the support of United Nations Children's Fund (UNICEF) under the project 'Effective Implementation of Children's Laws in Odisha':

Refresher Training for Legal Cum-Probation Officers

The Programme was held during 5- 6 September 2017 in partnering with Odisha State Child Protection Society, Department of Women & Child Development, Government of Odisha. The key objective of the training was to develop skills and knowledge for Effective Probation, Social Investigation, Individual Care Plan and Strategizing Rehabilitation. 28 LPOs of the District Child Protection Units in Odisha from equal number of districts participated in the programme.

Refresher Programme for Social Workers

The refresher programme was held during 14-15 September 2017 on Enhancing Social Works Skills on Juvenile Justice in partnering with Odisha State Child Protection Society, Women and Child Development Department, Government of Odisha. Training was attended by the social workers of the District Child Protection Unit of all 30 districts of Odisha State. Key objective of the training was to impart knowledge on the social work professionalism and to inculcate a right-based attitude and understanding among the social workers in dealing children. The training helped to improve skills and competency for effective social work, individual care plan, social inquiry, and rehabilitation plan for children in the perspective of the Juvenile Justice (Care and Protection of Children) Act, 2015.

Refresher Training for the Protection Officer for Institutional Care

The programme was held during 12-13 October 2017 in collaboration with OSCPS, DWCD, and Government of Odisha. The programme aimed to enhance skills for quality and effective management of institutional services to children. A total of 28 Protection Officer- IC participated in the program.

Refresher Training for the Protection Officers for Non-Institutional Care

The Refresher Training was held during 23-24 November 2017 on Enhancing Skills for Effective Management of Non-Institutional Services. The training was participated by the PO NIC from 28 districts of Odisha.

Research report entitled Effective Disposal of Cases in Juvenile Justice Boards in Odisha

The Report has been brought out by the Centre for Child Rights analysing pendency of juvenile cases and the challenges that impede effective case disposition.

Consultation on Right to Education: Effective Implementation, Outcomes and Challenges

The Centre for Child Rights organised one-day consultation on Right to Education: Effective Implementation, Outcomes and Challenges on the 17th February 2018 with the support of Indian Council of Social Science Research (ICSSR) under the research on Exploring Changing Dynamics of Children's Laws in India in Post-Liberalization Era. The consultation was attended by 40 Block Education Officers representing six districts of Odisha namely Cuttack, Ganjam, Keonjhar, Koraput, Sundergarh and Puri. The consultation provided critical inputs in the domains of universal elementary education, quality education, curriculum, pedagogy and evaluation, learning environment, and governance & accountability for the effective implementation of Right of Children to Free and Compulsory Education Act, 2009.

Technical and handholding support to the DCPUs

The Centre for Child Rights provided technical and handholding support to the DCPUs of Jagatsinghpur, Jajpur, Khurda, Gajapati, Balangir, Kendrapara, Keonjhar, Raygada and Puri for the capacity building training to various functionaries on Juvenile Justice (Care and Protection of Children) Act, 2015 and POCSO Act.



Centre for Research on Higher Education

The University has established the Centre for Higher Education. The centre is presently working on Litigation Management project in collaboration with Department of Higher Education, Government of Odisha. The centre is studying on numbers of cases filed in courts every month, records of the pending cases in several departments of the Government of Odisha. This project work commenced on February 20, 2017 and funded by World Bank. It will help the Government of Odisha in monitoring all the cases ongoing against the state in addition to better utilisation of resources.

Centre for Access to Justice

The University is promoting for the socially relevant education in field of Law. The Access to Justice Centre is a flagship initiative of the University. The Centre is under the working under the immediate guidance of Prof. (Dr.) Sri Krishna Deva Rao, Vice-Chancellor who is contributing enormously to the field of Access to Justice from last three decades. In furtherance of these objectives the centre is regularly various workshops, seminars and conferences. The centre has organised an International Conference on "Rethinking Socially Relevant Legal Education: Best Practices and a Way Forward" on 16th and 17th of September, 2017. The Conference was organised to mark the conclusion of the 3 years' DoJ-Gol-UNDP sponsored project on "Access to Justice for Marginalised People and Socially Relevant Legal Education: The centre has also released the report on "Access to Justice for Marginalised People and Socially Relevant Legal Education: An Overview."

The centre has also organised a series of lectures for Australian Students in collaboration with Centurion University from 5th to 21st January 2018. As part of the study abroad programme. The team of bachelors of law students from Victoria University (Australia) along with a faculty member participated to understand the constitutional principles and provisions which guides executive, Judicial and legislative matters in the country. The students gained knowledge on identification and evaluation of operational structures and interplay of a wide variety of factors like class, caste and gender. It also facilitated discussion on contemporary issues in Indian law and Justice.



5[™]International Maritime Law Arbitration Moot

The 5th edition of the National Law University Odisha International Maritime Arbitration Moot, 2018 (NLUO-IMAM) hosted by the University during 30th March -1st April, 2018.

This year's proposition has been drafted by Prof. Proshanto Mukherjee (Prof. Emeritus, WMU / Dalian Law School / Lund Law Faculty) with the assistance of Mr. Pallab Das, Research Associate cum Teaching Assistant, NLU Odisha.

NLUO-IMAM holds the distinction of being the first international maritime law moot in India with a special focus on international commercial arbitration, a subject specifically chosen not only to encourage intellectual discourse in this field but also to bring it in harmony with the stature of the State of Odisha, being the hub of maritime activities and operations.

This edition of NLUO-IMAM was based on maritime arbitration pertaining to a charter-party dispute. Dealing with the core maritime law issues, this edition provides participants with the opportunity to argue before an arbitral tribunal comprising of leading experts and practitioners in the concerned field of law.

The participants were made to go through extensive Mooting Rounds, to ensure that only the two best Teams reach the Final Round of Arguments. The Competition was conducted over 3 days where the participating teams went through Preliminary Rounds, the Quarter-Final Rounds, the Semi-Final Rounds and the Final Round. The judges of the final rounds were Hon'ble Dr. Justice B. R. Sarangi, Judge, Orissa High Court, Hon'ble Mr. Justice V.V.S Rao, Former Judge, High Court of Andhra Pradesh.

The university is committed to achieve excellence in the field of academics and to serve the society by means of social outreach programmes. To promote excellence in academics the university organised several conferences, trainings, workshops and literacy programmes. There were some notable academic events conducted in NLUO during 2017-18 which are given below:

International Conference on "Rethinking Socially Relevant Legal Education: Best Practices and a Way Forward" 16th and 17th of September, 2017

The University has organised an International Conference on "Rethinking Socially Relevant Legal Education: Best Practices and a Way Forward" on 16th and 17th of September, 2017. The Conference was organised to mark the conclusion of the 3 years' DoJ-GoI-UNDP sponsored project on "Access to Justice for Marginalised People and Socially Relevant Legal Education." The Conference was inaugurated by Hon'ble Dr. Justice B.R. Sarangi, Judge, Orissa High Court in the presence of Prof. Krishnadas Sukumaran from Keele University, UK.

Prof. Srikrishna Deva Rao, Vice-Chancellor, National Law University Odisha, Cuttack, Dr. Dolly Jabbal, Registrar, NLUO and Ms. Suman Dash Bhattamishra, Principal Coordinator of the project were present in the inauguration along with Ms. Geetanjali Dhankar, Project Head of the UNDP project. In the inaugural session, a project report titled "Access to Justice for Marginalised People and Socially Relevant Legal Education: An Overview" was released by the Chief Guest, Hon'ble Dr. Justice B.R. Sarangi.

During the Conference, about 40 participants from India and abroad deliberated on various issues Members of various Civil Society organisations, lawyers, academicians, representatives of the DoJ and A2J team of UNDP and several other stakeholders participated in the proceedings of the Conference.

The Valedictory address was delivered by Mr. Colin Gonsalves, Senior Advocate, Supreme Court of India.



Workshop on Maritime Law: Environmental Salvage, July 19, 2017

A workshop was organised on July 19, 2017 on "Maritime Law: Environmental Salvage". The resource persons to the workshop were Emeritus Prof. (Dr) Proshanto Mukherjee and Ms. Huiru Liu, World Maritime University, Sweden. The workshop has witnesses healthy discussion on the current topic of Maritime Law and Environmental Salvage.

Behavioural Training for Non-Teaching Staff, July 22, 2017

A Training Programme on Behavioural Competency for the administrative staff of the University was conducted on 22-07-2017. The training programme was conducted to boost the morale of the employees and to take better decisions. It focused on positive attitude of the employees at work. The training includes the importance of good communication skills and development of leadership skills. Workshop on Admiralty Jurisdiction in India and Recent Developments, April 11, 2017

The workshop on "Admiralty Jurisdiction in India and recent developments" was conducted on April 11, 2017. The experts have discussed the historical development of maritime law in England and in India, the importance and enforcement of admiralty jurisdiction by port states in India and the various maritime claims that shipping trade brings forth. The workshop also witnessed a detailed discussion on the new The Admiralty (Jurisdiction and Settlement of Maritime Claims) Bill, 2016 which has been recently passed by the Lok Sabha. The chief panelist of the workshop were Mr. Siddharth Ranka and Mr. Sujan Malhotra, senior legal members from Scorpio Marine Management Private Limited, Mumbai, a prominent shipping company who conducted the day long sessions and Mr. U. R. Mohan Raju, Secretary, Paradeep Port Trust, Odisha who discussed the importance of Port management and its policy influences in the maritime industry.



LEGAL SERVICE CLINIC

NLUO's Legal Services Clinic is intended to serve the legal needs of those who do not have the means to hire an advocate for consideration of their problem as well as for advice and action for appropriate relief. It intends to collaborate with Odisha State Legal Services Authority to facilitate services more effectively. The clinic is run by the students and faculty members of NLUO. Legal literacy and legal training workshops for the poor are some of the techniques used by the clinic to ensure that the marginalised receive adequate legal remedy. For the last four years, students have set up legal awareness camps in various parts of Odisha.

- The university has actively working Legal Aid Committee which is a student body. Student members of the Legal Aid Committee have been associated with the UNDP project as volunteers. Under the project, they have organised very successful Legal Literacy Camps in remote areas of Cuttack and Khurda. The Committee has played a very significant role in raising general awareness of rights and law in remote communities across the state of Odisha by organising Legal Literacy Programmes in innovative ways, thereby making the community receptive to the content of basic statutes and legislations. The Legal Aid Committee has several initiatives, these are:
- Counselling Programme for Prison Under trials: The Legal Aid Committee is initiating a legal
 awareness counselling programme for prison undertrials. It is also planning to set up legal aid
 camps in rural and socially backward areas in Odisha to spread legal awareness among
 citizens. These camps shall act as a medium to settle dispute by means of alternative dispute
 resolution.
- Publications: With an idea to make sure that those both inside and outside the legal fraternity understand the significance of legal aid, the Legal Aid Committee will come up with its own publications. These will be in the form of newsletters and brochures. Apart from these, a blog shall also be started, which will feature brief write-ups on various socio-legal issues.
- Legal Helpline: Another initiative of the Legal Aid Clinic programme of NLUO is about a legal
 helpline. Right now it is still a work in progress. However, considerable progress has been
 made in this regards, and the University hopes to commence services very shortly.

In a world which is evolving at a faster rate than at point of time in human history, the vulnerable sections of the society face a substantial challenge against majoritarian policies.

Journal of Rights of the Child

The Journal of Rights of the Child of National Law University is a biannual journal published by the Centre for Child Rights of the university. The journal is committed for research in the field of rights of the Children both at national and international levels.

NLUO Student Law Journal

The NLUO Student Law Journal is the flagship student-run publication of university. It is anannual, peer-reviewed journal. While it accepts (in fact, encourages) legal writing and scholarship of all types, it underscores the need for research on inter-disciplinary legal issues with an empirical focus.









CAMPUS INFRASTRUCTURE

The Campus of NLUO is near Naraj Barrage, at the western extreme of Cuttack. The area is noted for its scenic beauty, as it is where the Mahanadi, one of India's mightiest rivers, branches off its distributary, the Kathjodi. The Naraj Reservoir is located just a tenminute walk away, and the locality boasts also of several other places of notable scenic beauty. The campus is spread over 50 acres, with twenty more acres scheduled to be added soon. Once completed, it will house about 1000 students along with faculty members and other staff. It is designed to be eco-friendly, incorporating features such as rain-water harvesting measures. The academic block, administrative block and the hostels are already functional. The administrative block and academic block is fully air-conditioned.

The university has excellent infrastructure with a large and spacious three floor academic block (1,27,398 sq. feet) with state of art and fully digitalised classrooms. The lecture halls are airy, spacious, well-lit, and comfortable. They feature state-of -the-art audio-visual equipment, including LCD projectors, dedicated sound systems, and electronic blackboards (which automatically generate printouts of what has been written on them). It goes without saying that these equipment are not meant to be mere showpieces. Courses are designed in order to make optimum use of them; as a result, Power Point presentations, film screenings, and other multimedia techniques form an integral aspect of NLUO's undergraduate and postgraduate curricula. The administrative block of University is fully Air Conditioned and have three floor separate building (29,643 Sq. feet). The university has two boys hostel with 540 rooms and two Girls hotels with 382 rooms. The second girls hostel was newly built during 2017-18 with 86 rooms. The university has sports complex where world class courts are prepared for playing volley ball, basket ball and lawn tennis. In addition to this the students have facility for playing table tennis and badminton inside the respective hostels. The university has also an amphitheatre with the capacity for accommodating 1200 people.

The construction of university was proposed in two phases. In first phase we have completed two boys hostels, one girls hostel, academic block, administrative block, amphitheatre, parking area and the library building is under construction. In second phase the university has commenced the building of new girls hostel cum PG hostel and the guest house. The construction of faculty quarters, quest house and VC residence will start very soon.

LIBRARY

NLUO's library is without doubt the University's pride and joy. In the duration of last nine years, it has achieved highest standards which are adequate for teaching and basic research purposes. It houses a collection of 14176 books, about 1807 primary legal texts (such as copies of bare acts, law commission reports, etc.), and more than a hundred law reports, academic journals and the like amounting to a total of 7581 individual volumes. Particular interest to law scholars are the acquisition of complete sets of older law reports such as the Law Reports (Indian Appeals), Moore's Indian Appeals, the Criminal Law Journal, Calcutta Weekly Notes, Columbia Law Review, Stanford Law Review, Law and Contemporary Problems, Lloyd's Law Reports, Michigan Law Review, Yale Law Journal etc. Unlike contemporary reports these are not readily available online, which make hard copies essential and irreplaceable.

Consequently, this collection acquired by NLUO is of inestimable value to researchers investigating legal developments of the last few centuries. In the academic year 2017-18 the university added 525 books in the library, 243 bound volumes of various journals, along with Bare Acts, CD ROMs and included 2 e-journals, i.e. Asian Journal of International Law and Journal of International Economic Law. The library started new subscription of four print Journals i.e. Indian Economic & Social History Review, Academy Law Review, Caravan, Mainstream Weekly. In addition to the above the NLUO library has 13 Databases including, SCC online, Manupatra, Hein Online, Westlaw India, JSTOR, Kluwer Arbitration, Kluwer Competition Law etc., 6 individual e-journals i.e. Asian Journal of International Law, Air and Space Law, Economic Political Weekly, Journal of International Economic Law, Journal of International Trade Law and Policy, Journal of World Trade along with few EBSCO ebooks and Oxford e-handbooks. These databases can be accessed by the faculty and students in the campus and also outside the university campus either through VPN or through remote login. Apart from this, NLUO library has a subscription to an anti-plagiarism software, turnitin.

The University gratefully acknowledges the generosity of individuals who have donated many valuable books and legal materials. A dedicated library building is under construction. It has been designed keeping in mind the finest that traditional Odia architecture has to offer and once it becomes operational, it promises to stock more than 2,00,000 books and over a thousand journals, making it one of the largest and most comprehensive law libraries in India.
